### **OVERVIEW:**

A full-time mediator and DR professional since 1994, Anne Grant practises dispute resolution and conflict management full-time as a Director of the firm Mediated Solutions Incorporated in Toronto. Ms. Grant's dispute resolution and conflict management practice includes – interventions such as mediation, fact-finding and facilitation; consulting and conflict management system design as well as education and training. Ms. Grant specializes in facilitating national meetings and resolving complex multiparty disputes and has presented on these topics nationally and internationally. She is author of the advocate's guide *Dispute Resolution in the Insurance Industry* (Canada Law Book 2001), is a contributor to the Lawyer's Weekly, and along with her partner Judi Clarkson, is a regular columnist for the Canadian Human Resources Reporter, Municipal World, Hospital News and Canadian Health Care Human Resources Newsletter.
